

Participation processes

We wish to engage the citizens of Barcelona in the tasks of government. Governments can no longer do everything, and can even less on their own. We need public awareness and engagement. We must be able to channel all the ideas, knowledge and increasingly expressed keenness to take part by our citizens.

To make possible, along with other initiatives, we have been organising participation processes through which allow city residents can contribute their knowledge and experience in forums for dialogue with municipal and social representatives. Participation processes have different aims, depending on whom or what they affect: a specific part of the population (children, new arrivals, the elderly, etc.) an area or specific community (district, neighbourhood, community plans, plans for the future, etc.) a sector or specific sphere (urban planning, sport, education, etc.). They can also have a general scope, such as the municipal action plans.

Any participation process requires contemplation of the information and communication stages, the matter under discussion and the options put forward, the stages for gathering proposals and contributions and giving an answer, explaining the decision finally adopted.

Rambla del Poble Nou remodelling process



A participatory process ultimately aimed at preparing the foundations for the lines of future action in the Rambla del Poblenou. Current terraces and issues relating to the Rambla's public spaces are the main stumbling blocks to an agreement with local residents over the municipal redevelopment work.

This morning saw Eduard Freixedes, the District Councillor of Sant Martí, and Carles Agustí, the Commissioner for Participation, explain the new stage in the Rambla del Poblenou's participation process.

The participatory consultation on the Rambla del Poblenou marks a new stage based on the monitoring committees for the Rambla's redevelopment that were set up in June 2012. Staying true to its electoral pledge to solve the Rambla del Poblenou's current problems, the municipal government presented the Rambla's improvement project at the Neighbourhood Council's meeting of June 2012. The establishment of a monitoring committee for the Rambla's development, involving the neighbourhood's resident associations, restaurant owners, retailers, associations, crafts people and local residents, was agreed to during that meeting. Ever since that first committee, decisions have been taken over where the kiosks should be located, where the monument to Dr Trueta should be moved to and where the crafts market should be based.

The Sant Martí district is continuing with the participatory process and entering a new stage. Today sees the start of the "Let's Talk about the Rambla del Poblenou" process, where distinct issues will be debated and voted on, corresponding to three priorities: terrace tables, future work on the Rambla de Taulat's section that stretches up to the sea and the type of surfacing to be used. Besides these priorities, other issues that local residents may wish to raise will also be open for discussion. Ten sessions will be held with various collectives and, once the participatory process has finished, the results of these meetings and the voting on the Rambla's redevelopment will be announced.



Remodelling Plaça de les Glòries



Residents' associations in the neighbourhoods round Plaça de les Glòries have constantly called for the redevelopment of the square and surrounding area. In response to that call, Barcelona City Council launched a participation process in 2003 to reach a consensus on a common project for this city icon. The "Commitment to Glòries" signed by residents' associations and the City Council in 2007 represented a joint undertaking with various goals and projects to be realised. The Amendment to the General Metropolitan Plan is the blueprint to what will be the future transformation of the Plaça de les Glòries and its surroundings. Three citizen workshops were held at the end of September and start of October to inform the municipal officers and politicians in charge of the redevelopment project about the opinions and needs of local residents, the rest of the city's population and the city's associations and organisations, on which basis the terms and conditions for the Invitation to Tender and the "Commitment to Glòries" document approved back in 2007 are established. The aim of the workshops is to inform the 10 tendering teams of architects of the opinions and needs of the surrounding areas' local residents, the rest of the city's population and the city's associations and organisations, based on the terms and conditions established in the Invitation to Tender and the "Commitment to Glòries" document approved back in 2007.

Pla Cor, the participatory process for the Rambla



A plenary on the Rambla on 14 June 2012 saw the presentation of the conclusions of the participatory work conducted along the following six lines: morphological, social, economic, mobility, knowledge and governance. These line-focused workshops, along with subsequent technical and policy reflection - besides each line's specific analysis - led to three conclusions that foreshadow the approach to be followed:

- Despite the differences between the six lines, many of their goals are cross-sectional.
- The smoothing running of the strategy proposed has to be ensured and networking must be the main method for the development.
- The Rambla cannot be considered without its adjacent neighbourhoods.

The Rambla has its own association with several unique dynamics. The participating associations point out that the Rambla's spirit needs to be preserved and warn that any attempt to create a brand-new Rambla will be a mistake and that what needs to be made is an organised, secure, pleasant and inclusive Rambla. Work carried out at the participative workshops, technical and policy has given rise to a series of strategic lines that set out the roadmap for the PLA COR:

- The Rambla Inspection Plan which will be responsible for monitoring and inspecting the District and ensuring coexistence on the Rambla.
- A regulatory framework for the Rambla, by regulating specifically on level of urban-planning and activities taking place on the Rambla.
- Mobility must be worked on as a comprehensive concept: public transport, private transport, pedestrians and connections on the Rambla.



Bus Network participatory meetings. Mobility and Districts Agreement



The introduction of the first stage of the new Bus Network was followed by the launching of an information and participation process to assess and implement the rest of the network's stages.

The first five new network bus lines went into service in October 2012. They are made up by two horizontal lines, two vertical lines and a diagonal line, extending the network by 88.8 km. Some 70,000 people are expected to be transported every day, representing almost 10% of the network's current number of passengers.

- H12 (Gornal - Besòs/Verneda), which replaces the 56 line.
- H6 (Zona Universitària - Fabra i Puig), which replaces the 74 line.
- V7 (Plaça Espanya - Sarrià), which replaces the 30 line.
- V21 (Passeig Marítim - Montbau), which replaces the 10 line.
- D20 (Passeig Marítim - Ernest Lluch), which replaces the route shared between the 57 and 157 lines

The other stages will be gradually implemented until all 28 high-performance lines are in operation

- 17 will be vertical (sea - mountain).
- 8 will be horizontal (Llobregat - Besòs).
- 3 more are radial and cross the above lines diagonally.



Barcelona City Council's Citizen Register

Barcelona City Council's Citizen Register is a tool for or a means of grouping together citizens who have demonstrate their willingness to take part in the city's affairs, so they can be part of the City Citizen Council or the Neighbourhood Council Monitoring Committee, which are consultative municipal participation bodies.

The City Citizen Council is Barcelona City Council's highest body for public consultation and participation, a forum where representatives of the City Council and the public discuss the main affairs of the city. Those who wish take part in this council are chosen randomly from the Citizen Register, and nominated by the mayor or mayoress.

The Neighbourhood Council is a territorial participation body for dealing with all the questions relating to the neighbourhood. The Neighbourhood Council Monitoring Commission is responsible for monitoring the issues raised at the Neighbourhood Council and drawing up the agenda for the following sessions. Citizens in the Citizen Register may be represented in this commission if there is a significant number of them in the neighbourhood.

The City Council periodically contacts people signed up to the Register and informs them of the main municipal affairs and issues relating to participation and associations in the city.



Barcelona City Council's Citizen Register

Barcelona City Council's Citizen Register is a tool for or a means of grouping together citizens who have demonstrate their willingness to take part in the city's affairs, so they can be part of the City Citizen Council or the Neighbourhood Council Monitoring Committee, which are consultative municipal participation bodies.

The City Citizen Council is Barcelona City Council's highest body for public consultation and participation, a forum where representatives of the City Council and the public discuss the main affairs of the city. Those who wish take part in this council are chosen randomly from the Citizen Register, and nominated by the mayor or mayoress.

The Neighbourhood Council is a territorial participation body for dealing with all the questions relating to the neighbourhood. The Neighbourhood Council Monitoring Commission is responsible for monitoring the issues raised at the Neighbourhood Council and drawing up the agenda for the following sessions. Citizens in the Citizen Register may be represented in this commission if there is a significant number of them in the neighbourhood.

The City Council periodically contacts people signed up to the Register and informs them of the main municipal affairs and issues relating to participation and associations in the city.
